INSTRUCTIONS FOR DISPOSAL OF SPECIAL WASTES AND INFORMATION ABOUT UNACCEPTABLE WASTES NEW RIVER SOLID WASTE ASSOCIATION

Appliances: Freon and capacitors must be removed before disposal. Contents must also be removed before arrival.

Asbestos: Contact Levy County Solid Waste at 352-486-3300 for instructions and disposal information...

Automobile Batteries: Take automotive batteries to your county's collections sites. They CANNOT be disposed of in the landfill.

Barrels & Drums/Plastic or Metal: The container must be completely empty, both ends be removed and crushed.

Chemical Containers: Example: Pesticide, herbicide, solvents, etc... These containers must be triple rinsed, free of any residue, empty, dry, and a hole punctured in the bottom (puncture must be visible). (MUST BE SEPARATED FROM THE REST OF YOUR MATERIALS)

Dead Animals: Must schedule an appointment to dispose of dead animals. Animals must be separated from all other materials.

Engines/Motors: Must be completely drained of all liquids; oil, gas, water, etc...

Freon and Propane Tanks: The valve in the tank must be completely removed, and the tank must visually be punctured. (MUST BE SEPARATED FORM THE REST OF YOUR MATERIALS)

All Buckets Regardless of content: Must have lids removed and be free of any liquids or hazardous wastes.

Gas/Flammable Containers: These must be triple rinsed, visually be punctured, and free of any residue. (MUST BE SEPARATED FROM THE REST OF YOUR MATERIALS)

Liquids: Florida law prohibits liquids from being disposed of in our solid waste facilities.

Liquids Filters: (Example: Used oil filters) Residents may cut away metal casing and drain filter well. Businesses: Used oil filters from commercial/industrial/institutional sources are prohibited from disposal in landfill.

Mixed Wastes:

CLASS I – Disposal of prohibited or vegetative wastes (yard waste) mixed with any other acceptable solid wastes will be charged the mixed load clean-up fees of \$25.00 per hour labor / \$100.00 per hour equipment and operator. Loads containing mixed wastes may be rejected or charged the special handling rate.

Oil: Waste oil can be disposed of at your county's collection site. Rinsed oil containers or any debris with oil residue may go to Class I.

Paint Cans: Water base paint cans only (oil base paint cans are prohibited). The lids must be removed and contents <u>must be completely dry.</u>

Pool Supply Containers: Containers must be rinsed, dry, lids removed, and a hole punctured in the bottom.

Tires: Clean tires only. (MUST BE SEPARATED FROM THE REST OF YOUR MATERIALS).

Mobile Homes: Must remove any white goods, tires, or any other prohibited wastes before disposal and schedule appointment.
